# Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2018 Amendment Order No.3 2024 (ref: TRO-55b-2023)

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) and (2), 4, 45, 46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.
