

**ROAD TRAFFIC REGULATION ACT 1984
BRIGHTON & HOVE CITY COUNCIL**

Brighton & Hove (Dyke Road) Waiting Restrictions Experimental Order 2019

Brighton & Hove City Council in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order may be cited as the Brighton & Hove (Dyke Road) Waiting Restrictions Experimental Order 2019 and shall come into operation on the 15th day of April 2019.
2. The Council's Executive Director Economy, Environment & Culture or any person authorised by him is authorised to modify or suspend the operation of this Order or any provision of it in accordance with the provisions of section 10(2) of the Act.
3. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 is amended as follows:


