Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 Amendment No.* 201*

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1) to (3), 4, and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 Amendment Order No. ** 201* and shall come into operation on the XX day of MONTH 201X.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2018 is amended as follows:

SCHEDULE 1 AMENDMENTS:

Part 1.1 No Waiting at Any Time

Delete the following items-

1194	Lewes Road	East	From the southern kerbline of the southern arm of St Martin's Place southwards for a 32.8 metres
1181	Lewes Road	West	From the southern kerbline of St Paul's Street southwards for 4.3 metres
1186	Lewes Road	West	From the southern kerbline of Inverness Road southwards for 4.5 metres

Add the following items-

Item No.	Road Name	Side	Description
1194	Lewes Road	East	From the southern kerbline of the southern arm of St Martin's Place southwards for a 47.5 metres
1181	Lewes Road	West	From the southern kerbline of St Paul's Street southwards for 11.5 metres
1186	Lewes Road	West	From the southern kerbline of Inverness Road southwards for 13 metres
1298a	Manor Close	East	From a point 5 metres north of the prolongation of the northern boundary wall of no.2 Manor Close southwards for 10 metres.

1298b	Manor Close	West	From a point 103 metres south of the southern kerbline of Manor Way southwards for a distance of 5 metres.
1994c	Southall Avenue	West	(on the traffic island) From a prolongation of the property boundary of 65 and 67 Southall Avenue southwards for 11 metres.
1994d	Southall Avenue	East	From the boundary 96 and 98 Southall Avenue northwards for 21 metres.

Delete the following items:-

1	Lewes Road	North west	From a point 3.5 metre north east of the north eastern kerbline of St. Martins Street north east for 23.6 metres
2	Lewes Road	West	From a point 4.5 metres south of the southern kerbline of Inverness Road southwards for a distance of 23 metres
3	Lewes Road	South east	From a point 33 metres south west of the south western kerbline of the southern arm of St. Martins Place south west for 8.2 metres

Add the following items:-

Item No.	Road Name	Side	Description
1	Lewes Road	North west	From a point 11.5 metres south of the southern kerbline of St Paul's Street southwards for 16 metres.
2	Lewes Road	West	From a point 13 metres south of the southern kerbline of Inverness Road southwards for a distance of 14.5 metres
3	Lewes Road	South east	From a point 33 metres south west of the south western kerbline of the southern arm of St. Martins Place south west for 8.2 metres
