

**BRIGHTON & HOVE CITY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove (Valley Gardens) Traffic Management Order 201\***

Brighton & Hove City Council in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall be cited as the "Brighton and Hove (Valley Gardens) Traffic Management Order 201\*".
2. The provisions of this Order will come into operation on the            day  
of                            201\*.
3. In this Order, except where the context otherwise requires, the following expressions have the meanings assigned to them:-
  - "**Pedal Cycle**" has the same meaning as in Regulation 4 of the Traffic Signs Regulations and General Directions 2002;
  - "**Taxi**" has the same meaning as in Regulation 4 of the Traffic Signs Regulations and General Directions 2002
  - "**Undertaker**" has the same meaning as in Section 48 (4) of the New Roads and Street Works Act 1991;
  -
4. Any reference in this Order to a numbered Article or a numbered Schedule is a reference to the Article or Schedule bearing that number in this Order unless specified otherwise.
5. No person shall except upon the direction or with the permission of a police officer in uniform cause or permit any vehicle to proceed in those lengths of road specified in column 2 of Schedule 1 to this Order other than in the direction specified in the adjoining section of column 3 of that Schedule
6. No person shall except upon the direction or with the permission of a police officer in uniform or person authorised by the Council cause or permit any vehicle to make a right turn on the lengths of road specified in column 2 of Schedule 2
7. No person shall except upon the direction or with the permission of a police officer in uniform or person authorised by the Council cause or permit any vehicle to make a left turn on the lengths of road specified in column 2 of Schedule 3

8. No person shall except upon the direction or with the permission of a police officer in uniform or person authorised by the Council cause or permit any vehicle to make a left turn on the lengths of road specified in column 2 of Schedule 4 with the exception of Local buses, taxis, pedal cycle and for the purposes of loading.
9. No person shall except upon the direction or with the permission of a police officer in uniform or person authorised by the Council cause or permit any vehicle to make a U-turn on the lengths of road specified in column 2 of Schedule 5
10. Articles 5, 6, 7, 8, and 9 shall not apply vehicles in the course of an emergency for fire service, ambulance service or police purposes or a vehicle in the service of a local authority in the course of road cleansing or gully emptying.
11. In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, and which imposes a restriction or prohibition on movement by vehicles or grants an exemption from such restriction or prohibition, the provisions of this Order shall prevail.
