**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018
Amendment Order No.* 202***

Brighton & Hove City Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 3, 4, , 45, 46, 49, 53, , and 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended and Part 6 of the Traffic Management Act 2004, Section 63 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2018 Amendment Order No.* 202* and shall come into operation on the XX day of MONTH 201*.
