

**ROAD TRAFFIC REGULATION ACT 1984
BRIGHTON & HOVE CITY COUNCIL**

Brighton & Hove (Queens Parade, Hove) (Waiting Restrictions) Experimental Order 2018

Brighton & Hove City Council in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order may be cited as the Brighton & Hove (Queens Parade) (Waiting Restrictions) Experimental Order 2018 and shall come into operation on the 3rd day of April 2018.
2. The Council's Executive Director Economy, Environment & Culture or any person authorised by him is authorised to modify or suspend the operation of this Order or any provision of it in accordance with the provisions of section 10(2) of the Act.
3. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2013 is amended as follows:

SCHEDULE 1 AMENDMENTS:

Part 1.1 No Waiting At Any Time

Delete the following:-

Item No.	Road Name	Side	Description
53	Applesham Avenue	Both	From the northern kerbline of West Way northwards for a distance of 17 metres

Replace with the following:-

Item No.	Road Name	Side	Description
53	Applesham Avenue	East	From the northern kerbline of West Way northwards for a distance of 16.5 metres
53a	Applesham Avenue	West	From the northern kerbline of West Way northwards for a distance of 16 metres

Part 5.5 Limited Waiting for 1 hour (No Return within 1 hour) Monday to Saturday 8am to 6pm

Delete the following:-

Item No.	Road Name	Side	Description
1	Applesham Avenue	West	From a point 25.5 metres north of the north-eastern kerbline of West Way northwards for a distance of 22 metres.

And replace with:-

Item No.	Road Name	Side	Description
1	Applesham Avenue	West	From a point 19.5 metres north of the north-eastern kerbline of West Way northwards for a distance of 30 metres (bays at angle of 45 degrees)

Part 6.1 Disabled Badge Holders Parking At Any Time

Delete the following:-

Item No.	Road Name	Side	Description
10	Applesham Avenue	West	From the boundary wall between Nos. 50 & 52 Applesham Avenue southwards for a distance of 5.5 metres (outside No.50)

And replace with:-

Item No.	Road Name	Side	Description
10	Applesham Avenue	West	From a point 16 metres north of the northern kerbline of West Way northwards for 3.5 metres (bay at angle of 45 degrees)

Part 10.1 Taxi Rank At Any Time

Delete the following:-

Item No.	Road Name	Side	Description
13	West Way	North	From a point 34 metres west of the western kerbline of Applesham Avenue westwards for 11 metres.

And replace with:-

Item No.	Road Name	Side	Description
13	West Way	South	From a point 32 metres from the western kerbline of Applesham Avenue for a distance of 13 metres.

Part 11.2 Loading Bay 8am to 6pm every day

Delete the following:-

Item No.	Road Name	Side	Description
1	Applesham Avenue	West	From a point 24 metres south of the access way between 4 and 6 Applesham Avenue, southwards for 11 metres.

And replace with:-



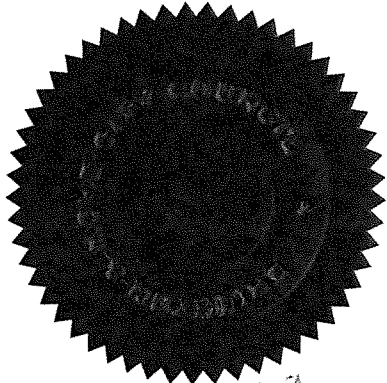
