Claim or end a discount, exemption or CTR

If you receive a discount or an exemption it will show on the front of this bill. You can apply for these at www.brighton-hove.gov.uk/council-tax/ **council-tax-discounts** including 25% single person discount, student exemptions, receiving or providing care and empty property awaiting probate. If your circumstances change, you must tell us straight away. If you get too much CTR, discount or exemption because you have not told us correct information, you will have to pay it back. You could also be committing an offence and could be prosecuted.
