ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove (Various Roads) (One Way) Traffic Order 2012 Amendment
Order No.* 202***

Brighton & Hove City Council in exercise of its powers under Sections 1(1), 2 (1) and (2) and 4 of the Road Traffic Regulation Act 1984 (“the Act”) as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall be cited as the “Brighton & Hove (Various Roads) (One Way) Traffic Order 2012 Amendment Order No.* 202* and shall come into operation on the DAY of MONTH 202*.
2. The Brighton & Hove (Various Roads) (One Way) Traffic Order 2012 is amended as follows:

Schedule - One Way (except pedal cycles)

Renumber existing items 1a to item 2, existing item 2 to item 2a and existing item 2a to 2b.

Insert new items as follows:

Item No.	Road	Description	Permitted Direction
1a	Castle Street	From its junction with Stone Street to its junction with Preston Street	Southwards and Westwards
9a	Hampton Place	From the junction with Hampton Street to its junction with Upper North Street	Northwards
9b	Hampton Street	Whole Length	Westwards
12b	Little Preston Street	From its junction with Western Road to its junction with Sillwood Street	Northwards

15a	Sillwood Road	Whole Length	Northwards
15b	Spring Street	From its junction with Upper North Street to its junction with Hampton Street	Southwards
15c	Stone Street	Whole Length	Eastwards

3. The following orders are amended as follows by this order:

- The Brighton (Various Roads) (One-Way Traffic) Order 1976 (order no.80); Schedule 1 - revoke items 1 Hampton Street, 2 Little Preston Street, 4 Stone Street and 5 Castle Street 2
- The East Sussex (Hampton Place/Little Preston Street, Brighton) (Traffic Regulation Order) 1985, revoke paragraph 5 in relation to Hampton Place.
- The Brighton & Hove (Access to Western Road) (Traffic Regulation) (Consolidation) Order 1998 Schedule 3 revoke item 3 Sillwood Road
- The Brighton Corporation (Spring Street) (One-Way Traffic) Order 1960 revoke Spring Street
