## **STATEMENT OF REASONS**

Valley Gardens Phase 3 is also a Local Transport Plan project which will complete the final and southern-most section of a strategic sustainable transport corridor that will contribute towards the council's and city's economic growth, regeneration, planning, public realm, and transport objectives.

The project also proposes to promote and facilitate smooth traffic flow of cyclists, pedestrians and vehicular users to the seafront and arterial routes northwards for sustainable forms of transport along the Royal Pavilion Gardens and Old Steine Gardens (local buses, taxis and cycles) and to allow the regeneration of the area as agreed by the Environment Transport & Sustainability Committee in November 2016.

Brighton & Hove City Council is proposing to introduce a signalised junction at Marine Parade and Grand Junction Road to replace the existing roundabout at this location.

It is also proposed that the northbound traffic on Old Steine along the Royal Pavilion Gardens is diverted onto the A23 which will carry the two-way traffic towards the junction with Edward Street. The eastern corridor will allow for 2-way traffic along the A23 so that the western corridor is free of general through traffic. This will allow significant regeneration of the green space and public realm space at Old Steine Gardens and the creation of a two new squares at Old Steine and Royal Albion.

The Valley Gardens order will ensure that existing loading and disabled provision is maintained or improved within the proximity of existing provision.
