**Note 1.** Anyone who holds a Personal Licence is required to notify the Licensing Authority, which issued their Personal Licence of any change of name or address. The Licensing Authority will then change the details on their Personal Licence and reissue the licence. It is a criminal offence not to notify the Licensing Authority of such changes.

**Note 2.** This address should be the address where you will normally live not where you work.

**Note 3.** You are required to send both parts of your Personal Licence in to us with this notification form. If you cannot do so you are required to make a statement in the box provided as to why you cannot.
