BRIGHTON & HOVE CITY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

Brighton & Hove (Traffic Management) (Western Road area, Brighton) Order No.1 2023

Brighton & Hove City Council in exercise of its powers under sections 1(1), 2(1) to (3), 4 and 124(1)(c) and (d) of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. This Order shall be cited as the "Brighton and Hove (Traffic Management) (Western Road Area, Brighton) Order No.1 2023".
- 2. The provisions of this Order will come into operation on the 4th day of September 2023.
- 3. In this Order, except where the context otherwise requires, the following expressions have the meanings assigned to them:-
- "Pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
- "Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on roads subject to Section 20 Chronically Sick and Disabled Persons Act 1970.
- 4. Any reference in this Order to a numbered Article or a numbered Schedule is a reference to the Article or Schedule bearing that number in this Order unless specified otherwise.
- No person shall except upon the direction or with the permission of a police officer in uniform cause or permit any motor vehicle to proceed in those parts of road specified in columns 2 and 3 in Schedule1.
- 6. In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, and which imposes a restriction or prohibition on movement by vehicles or grants an exemption from such restriction or prohibition, the provisions of this Order shall prevail.

- 8. The following Orders are amended as followed by this order:-
 - The Brighton & Hove (access to Western Road) (Traffic Regulation)
 (Consolidation) Order 1998 revoke item 2 in Schedule 6 Spring Street.
 - The Brighton (Various Roads) (Prohibition of Entry) Order 1976 revoke items relating to Castle Street into Western Road and Western Road into Castle Street.
