

**ROAD TRAFFIC REGULATION ACT 1984
BRIGHTON & HOVE CITY COUNCIL**

Brighton & Hove (Various Restrictions) (Downs Junior) Order 2024 (TRO-27b-2022)

Brighton & Hove City Council in exercise of its powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall be cited as the "Brighton & Hove (Various Restrictions) (Downs Junior) Order 2024".
2. The provisions of this Order will come into operation on the 15th day of February 2024.
3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.
4. In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, and which imposes a restriction or prohibition on movement by vehicles or grants an exemption from such restriction or prohibition, the provisions of this Order shall prevail.
5. No person shall except upon the direction or with the permission of a police officer in uniform cause or permit any vehicle (not including pedal cycles) to proceed in those lengths of road specified in column 2 of Schedule 1 to this Order other than in the direction specified in the adjoining section of column 3 of that Schedule except in the case of a vehicle in the course of an emergency for fire service, ambulance service or police purposes or a vehicle in the service of a local authority in the course of road cleansing or gully emptying.
6. No person shall except upon the direction or with the permission of a police officer in uniform cause or permit any motor vehicle to proceed in those parts of road specified in columns 2 and 3 in Schedule 1 other than a pedal cycle.
