

**ROAD TRAFFIC REGULATION ACT 1984
BRIGHTON & HOVE CITY COUNCIL**

Brighton & Hove (Red Routes) (Lewes Road) Experimental Order 2024 (TRO-4-2024)

Brighton & Hove City Council in exercise of its powers under sections 1(1), 2(1), 4, 9, 10, 45, 46, 49, 53, 124 (1) (c) & (d) of the Road Traffic Regulation Act 1984 ("the Act") as amended and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order may be cited as the Brighton & Hove (Red Routes) (Lewes Road) Experimental Order 2024 and shall come into operation on the 15th day of April 2024.
2. The Council's Executive Director Economy, Environment & Culture or any person authorised by him is authorised to modify or suspend the operation of this Order or any of it in accordance with the provisions of section 10(2) of the Act.
3. In this Order, except where the context otherwise requires, the following expressions have the meanings assigned to them:-
 - **"Authorised Person"** means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;
 - **"Blue Badge Scheme"** means the national arrangement of parking concessions for disabled and blind persons as described in the Chronically Sick and Disabled Persons Act 1970 (as amended);
 - **"Emergency Service Vehicle"** means a vehicle operated by the police, fire & rescue service or ambulance service;
 - **"Taxi"** has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
 - **"Motor Vehicle"** means a mechanically propelled vehicle intended or adapted for use on roads subject to Section 20 Chronically Sick and Disabled Persons Act 1970;
 - **"Private Hire Vehicle"** has the same meaning as in Section 80 of the Local Government (Miscellaneous Provisions) Act 1976;

- **“Restricted Road”** means any road or part of a road specified in Schedule 1 to therein in which access is restricted by reference to time and/or place and/or day in accordance with the provisions of this Order;
- **“Road marking”** means a traffic sign consisting of a line or mark or legend on the surface on the road of a size, colour and type prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;
- **“Traffic Signs Regulation and General Directions”** means the Traffic Signs Regulation and General Directions 2016 as amended from time to time;
- **“Traffic Sign”** means a sign of a size, colour and type prescribed or authorised under, or having an effect as though prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984;
- **“Undertaker”** has the same meaning as in the meaning ascribed to it in section 48 of the New Roads and Street Works Act 1991;

4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.

5 In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes into operation, and which imposes a restriction or prohibition on movement by vehicles or grants an exemption from such restriction or prohibition, the provisions of this Order shall prevail.

6. Subject to the provisions of Article 7 of this Order no person shall except upon the direction or with the permission of a Civil Enforcement Officer Police Constable in uniform or person authorised by the Council cause or permit any vehicle to park, stop or wait in the parts of the Restricted Road as detailed in Schedule 1.

Nothing in Article 6 of this Part shall prevent any person from using causing or permitting a vehicle to stop or wait in a Restricted Road on the lengths detail in Schedule 1;

- a) To enable a vehicle to be parked in the course of an emergency by Emergency Service Vehicles.
- b) To enable a vehicle (if it cannot reasonably be used for the same purpose in any other road) to be used in connection with any of the following operations in an emergency: building works; the removal of any obstruction to traffic; the maintenance, improvement or reconstruction of the road; the laying, erection, alteration or repair in or adjacent to the road by an Undertaker of any sewer or of any main,

pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus.

- c) To enable a vehicle in the service of a local authority for the purpose of collecting refuse and/ or recycling from premises adjacent to restricted section of road.
- d) To enable a vehicle which is loading or unloading scaffolding or glazing to a premises immediately adjoining a restricted section of road and if that vehicle cannot reasonably be used for the same purpose in any other road.
- e) To enable a blue badge holder to board or alight from the vehicle provided that the vehicle cannot reasonably be used for the same purpose in any other road.
- f) To enable Taxis and Private Hire Vehicles to enable their passengers to board or alight from the vehicle provided that the vehicle cannot reasonably be used for the same purpose in any other road.


