### **ROAD TRAFFIC REGULATION ACT 1984**

#### **Brighton & Hove (Off-Street Parking Places) Consolidation Order 2019 Amendment No.\* 202\* (TRO-2024)**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 32, 35 and 124 (1) (c) & (d) to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

2. Brighton & Hove (Off-Street Parking Places) Consolidation Order 2019 is amended as follows:

#### **SCHEDULE 1 AMENDMENTS**

##### **Part 1.1 Parking Places with No Barrier on Entrance/Exit**

Item 5 Norton Road in Column '(6) Tariffs' make the following changes:

Delete "Staff annual permit" and charge

##### **Part 1.2 Parking Places with Barrier on Entrance/Exit**

Item 1 The Lanes Car Park

In Column '(6) Tariffs' make the following changes:

Delete "24 hours" and replace with "24 hours/ Lost Ticket (Charged 24hrs where time of entry cannot be verified) for both week and weekend entries

Delete "lost ticket" and charge.

Add in new row and add "Monthly Season Ticket" – and add charge "£360.00" 

Delete "Reduced charge annual season ticket 16.00 to 11.00 Monday to Friday (for residents on a waiting list for resident parking permit for Controlled Parking Zone Z)" and charges.

Item 2 London Road Car Park

In Column '(6) Tariffs' make the following changes:

Delete" 24 hours" and replace with "24 hours/ Lost Ticket (Charged 24hrs where time of entry cannot be verified)

Delete "lost ticket" and charges.

Delete "Reduced charge annual season ticket 16.00 to 11.00 Monday to Friday (for residents on a waiting list for resident parking permit for Controlled Parking Zone Y)" and charges.

Add in new row and add "Monthly Season Ticket" – and add charge " £175.00"

### Item 3 Regency Square Car Park

In Column '(6) Tariffs' make the following changes:

Delete" 24 hours" and replace with "24 hours/ Lost Ticket (Charged 24hrs where time of entry cannot be verified)

Delete" lost ticket" and charges

Delete "Weekly season ticket" and charges

Add in new row and add "Monthly Season Ticket" – and add charge "£160.00"

Delete "Reduced charge annual season ticket 16.00 to 11.00 Monday to Friday (for residents on a waiting list for resident parking permit for Controlled Parking Zone M)" and charges.

### Item 4 Trafalgar Street Car Park

in Column '(6) Tariffs' make the following changes:

For the parking period and parking charge delete the following Monday to Friday and replace with Monday to Sunday. Delete the Weekend column.

Add in new row and add "Monthly Season Ticket" – and add charge" £175.00"

Delete "Reduced charge annual season ticket 16.00 to 11.00 Monday to Friday (for residents on a waiting list for resident parking permit for Controlled Parking Zone Y)" and charges.
