Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No.1 2024 (TRO-47-2023)

Brighton & Hove City Council (“the Council”) in exercise of its powers under Sections 1(1), 2 (1) and (2), 4,124 (1) (c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No.1 2024 and shall come into operation on the 13 day of May 2024.
2. Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 is amended as follows:

SCHEDULE 1 AMENDMENTS:

Part 1.1 No Waiting At Any Time

Revoke the following items:-

Item No.	Road Name	Side	Description
1761	Old Shoreham Road	South	From a point 261.5 metre west of the western kerbline of Carlton Terrace to a point 17 metres east of the city boundary with West Sussex.

Add the following new items:

Item No.	Road Name	Side	Description
1761	Old Shoreham Road	South	From a point 260 metres west of the western kerbline of Carlton Terrace to a point 6.6 metres east of the western boundary of No.7 Old Shoreham Road
1761a	Old Shoreham Road	South	From the city boundary with West Sussex eastwards to the western boundary of No.7 Old Shoreham Road

Part 6.1 Disabled Badge Holders Parking At Any Time

Revoke the following item:

Item No.	Road Name	Side	Description
549	Old Shoreham Road	South	From a point 10 metres west of the boundary wall between Nos. 5 and 7 Old Shoreham Road westwards for a distance of 5.5 metres (outside Nos. 1-3)


Add new item as follows:

Item No.	Road Name	Side	Description
549	Old Shoreham Road	South	From the western boundary of No.7 Old Shoreham Road eastwards for 6.6 metres (outside No.7)
