

**BRIGHTON & HOVE CITY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes  
Consolidation Order 2024 Amendment Order No. \* 202\* (ref: TRO-07c-2024)**

Brighton & Hove City Council (“the Council”) in exercise of its powers under sections 1(1), 2(1) to (3), 4, 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No. \* 202\* and shall come into operation on the            day of            202\*.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 is amended as follows:

**SCHEDULE 1 AMENDMENTS:**  
**Part 16.1 Cycle Lanes At Any Time**

Delete the following:-

27	London Road (A23)	West	Northbound from the northern kerbline of Brangwyn Crescent northwards to the southern kerbline of the southern entrance to Patcham Place
28	London Road (A23)	West	Northbound from the northern kerbline of Brangwyn Drive northwards to the southern kerbline of Brangwyn Crescent
29	London Road (A23)	West	Northbound from the northern kerbline of the entrance to “Homeleigh” northwards to the southern kerbline of Brangwyn Drive
30	London Road (A23)	West	Northbound from the northern kerbline of the northern entrance to Patcham Place northwards for 6 metres
31	London Road (A23)	West	Northbound from the northern kerbline of the southern entrance to Patcham Place to the southern kerbline of the northern entrance to Patcham Place
34	London Road (A23)	East	Southbound from the southern kerbline of Old London Road (North) southwards to the northern kerbline of the northern entrance to the ESSO Service Station
35	London Road (A23)	East	Southbound from the southern kerbline of Ridgeside Avenue southwards to the northern kerbline of the access road into The Woodlands and South Woodlands
36	London Road (A23)	East	Southbound from the southern kerbline of the access road into The Woodlands and South Woodlands southwards for 80 metres
37	London Road (A23)	East	Southbound from the southern kerbline of the northern entrance to the ESSO Service Station to the northern kerbline of the southern entrance to the ESSO Service Station
38	London Road (A23)	East	Southbound from the southern kerbline of the southern entrance to the ESSO Service Station southwards to the northern kerbline of Old London Road (South)

Add the following:-

27	London Road (A23)	West	From the northern kerbline of the access to "Homeleigh" northwards to the southern kerbline of Brangwyn Way.
28	London Road (A23)	West	From the northern kerbline of Brangwyn Way northwards to the southern kerbline of Brangwyn Crescent
27	London Road (A23)	West	From the northern kerbline of Brangwyn Crescent northwards to a point 6 metres north of the northern kerbline of the northern access to Patcham Place.
34	London Road (A23)	East	From the southern kerbline of Old London Road (northern junction) southwards to the northern kerbline of the northern access to the Esso Service Station.
35	London Road (A23)	East	From the southern kerbline of the northern access to the Esso Service Station southwards to the northern kerbline of the southern access to the Service Station
36	London Road (A23)	East	From the southern kerbline of the southern access to the Esso Service Station southwards to a point 28 metres south of the southern kerbline of Brangwyn Crescent.
37	London Road (A23)	East	From a point 7.36 metres south of the access to Brangwyn Way southwards to the northern kerbline of the access to The Woodlands/South Woodlands
38	London Road (A23)	East	From the southern kerbline of the access to The Woodlands/South Woodlands southwards for 80 metres
