## Dear Toni

The West Hove Seafront Action Group (WHSAG) fully supports the Council's *Kingsway to the Sea* project as it would provide the resources to further develop and deliver a phased *West Hove Seafront Improvement Plan* which has been gradually evolving through our joint work with the Council over the past three years.

In 2018 a West Hove Forum project focused attention on growing community concerns about the neglected and deteriorating West Hove Seafront - the West Hove Lawns and Esplanade between King Alfred's Sports Centre and Hove Lagoon. A report was produced which identified a wide range of problems with the infrastructure of the area – in particular the underused lawns and the lack of both public and private investment in the run-down buildings along the promenade.

But the report also highlighted the enormous potential for improving the area to deliver outdoor sports and leisure opportunities for the local West Hove community and for visitors from elsewhere in city. The conclusion was that there was a need for a West Hove Seafront Improvement Plan. This would provide both a stimulus and a framework for the regeneration of the area through an evolving variety of projects which would adapt the historic lawns and the esplanade to meet contemporary community needs and aspirations.

The report was endorsed at a public meeting which attracted over 100 participants including both representatives of seafront businesses and residents from the neighbourhoods immediately north of Kingsway. The West Hove Seafront Action Group was formally constituted to press for Council action – see attached membership list. Initial discussions established partnership working between with the Council officers and a process for developing a West Hove Seafront Improvement Plan. It was agreed that the first priority would be a landscape design project to provide a coherent framework for upgrading the Western Lawns. This approach was fully supported at was agreed at a second public in early 2020, with over 130 participants. However, with the onset of the pandemic it was not possible for the Council to the fund necessary consultancy work.

Earlier this year it was possible to resume this participatory planning process. The Council has been able to appoint consultants for the landscape design project. WHASG was involved in the development of the brief for the consultants and the

inception meeting which established s process of community engagement in the development of the landscape design. There is some justifiable optimism about the outcome of this project and the Council's commitment to a second stage in the development of the Improvement Plan which will focus on the challenge of upgrading the Esplanade.

However, the delivery of a transformative regeneration of the West Hove Seafront will require significant public sector investment which will stimulate further private investment. WHSAG is fully aware of the competing demands on limited Council resources for the implementation of an action programme. Thus we fully support this bid which will build enable the Council to build on three years collaborative work to support the post-Covid recovery of the West Hove seafront.
