### Declaration

- I confirm that I have shown a copy of my child's birth certificate to my early years/childcare provider
- I understand that their EYFE is a maximum of 15 hours a week, 38 weeks a year
- I understand that the EYFE may be stretched across the whole year for a total of 570 hours. If my child's EYFE is stretched this will be for more than 38 weeks a year but for fewer than 15 hours a week
- I understand that if my child attends more than one childcare setting (including a maintained school nursery class) their EYFE hours cannot exceed 570 hours a year
- I understand that if my child leaves their early years/childcare setting I must give the setting notice as required by their notice policy, and that I may be charged by the provider if I do not
- I understand that this form will be made available by my early years/childcare setting to Brighton & Hove city council (BHCC) upon request
- I understand that the information I have supplied regarding EYPP will be used by Brighton & Hove city council to check for EYPP eligibility. It will be used for no other purposes and remain confidential to BHCC
- I understand that I will have to complete a change of attendance form if my child's EYFE hours vary from those outlined on this form.
