A migrant is defined as a person whose address one year before the census was different from their address on census day (April 29th 2001). Migrants are people who either moved into the area, out of the area or within the area in the year before the census was undertaken. Eighteen percent of the population of the city (or 44,893 people) were migrants according to this definition. This places Brighton & Hove as the area with the highest percentage of migrants in the South East and the 15th highest percentage nationally. The highest percentage of migrants were residents who moved within the area (9.4%). In total 17,808 people moved into the area within the year preceding the census. Most of these people (14,578 people) moved into the area from within the UK, 3,230 people moved into the area from outside the UK. In total, 12,669 people moved out of the area in the year preceding the census. This gave the city a net in-migration of 5,139 people over this period (i.e. 5139 more people came into the city than moved out of the city).

From the 2001 Census it is possible to distinguish between migrants from different ethnic groups. In Brighton & Hove there are a total of 14,235 residents from ethnic groups other than white. Of this group nearly a third (29.8%) were migrants (compared with the figure of 18% for the city as a whole). This is higher than the percentage of all people in ethnic groups other than white who are migrants in the South East as a whole and considerably higher than the percentage for England & Wales. This means that people of ethnic groups other than white are far more likely to move, either within the city or in or out of the city, than people of white ethnic background. Thirteen percent of the non white population of the city (or 1,865) moved within the area in the year preceding the census. A total of 1,997 people of non white ethnic background moved into the area, the majority from the rest of the UK, compared with 1,112 who moved out of the area. This gives a net in-migration of 885 people in ethnic groups other than white. (i.e. 885 more people of non white ethnic background moved into the city than moved out of the city.)
